General Terms & Conditions


- i. The bidders may inspect the items on a predetermined date and satisfy themselves about the items they are bidding for.
- ii. The items shall be sold to the highest bidder.
- iii. The Earnest Money Deposit (EMD) of the unsuccessful bidders shall be returned within one month, without any interest.
- iv. No items, once disposed to the successful bidder, shall be taken back by the Department of Land Resources, on any condition whatsoever.
- v. The successful bidder has to make full balance payment in the form of Demand Draft in favor of Pay & Accounts Officer, Department of Land Resources, Ministry of Rural Development within 3 days after confirmation, failing which the offer will be cancelled and EMD shall stand forfeited.
- vi. The successful bidder shall be required to lift all the items from the disposal site to his premises within 2 days after the payment of the payment of the balance amount. On failure to do so, Department of Land Resources, shall have the right to forfeit the entire EMD of the bidder.

1. Tender letter in sealed envelope should be addressed to Under Secretary (Admn.) Department of Land Resources, Ministry of Rural Development, NBO Building, 'G' Wing, Nirman Bhawan, New Delhi-110011.
2. Tender received after the stipulated date and time due to any reasons whatsoever including postal delays shall not be considered.
3. Department of Land Resources reserves the right to accept or reject any/all Tenders without assigning any reason whatsoever.
4. The tender document should be signed by the bidder(s).
5. Incomplete and unsigned Tenders are liable to be rejected.
6. An Earnest Money Deposit (EMD) of Rs.5000 (Rupees Five Thousand only) must accompany each Tender. This shall be in the form of an account payee Demand Draft of any nationalized bank drawn in the name of Pay & Accounts Officer, Department of Land Resources payable at New Delhi without which the tender shall be summarily rejected. No cheque/ money order/cash shall be accepted.
