In addition to structured discussion on the Agenda, the programme will also include:


(a) A 15-minute **inaugural address** by Hon'ble Union Minister of Rural Development, Panchayati Raj and Drinking Water & Sanitation.

(b) A 30-minute presentation-cum-talk on **Land Administration in India and Integrated Land Information Management System under the aegis of DILRMP** by Secretary Land Resources, Government of India.

(c) A 30-minute presentation on an **All-encompassing comprehensive project for both rural and urban areas in the UT of Chandigarh under the aegis of DILRMP** by Deputy Commissioner, Chandigarh.

[The project in Chandigarh is computerizing land records in both rural and urban areas and is integrating the processes of registration with land records as well as connecting Aadhaar number with the land records database. In addition, the UT Administration is also attempting to include information on circle rate and revenue court cases in the land record database and to put in place a system to ensure real-time updation on continuous basis. It is also endeavouring that publication / notice for mutation is immediate and automatic on receipt of information of registration.]

(d) A 15-minute presentation on **technical aspects of the DILRMP** (including mapping of Census 2011 Codes in State Land Records and Registration databases, on which States/UTs are already working on) by NIC, DoLR.
