



**Minutes of the 38<sup>th</sup> Meeting of the Steering Committee on Integrated Watershed Management Programme (IWMP) held on 10<sup>th</sup> November, 2014 at Nirman Bhawan, New Delhi**

The 38<sup>th</sup> Meeting of the Steering Committee on Integrated Watershed Management Programme (IWMP) was held on 10<sup>th</sup> November, 2014 at 11.00 AM under the Chairpersonship of Secretary (LR) in the Committee Room of the Department of Land Resources at NBO Building, Nirman Bhavan, New Delhi. The list of participants is at **Annexure I**. The DIGF (WM), Department of Land Resources welcomed the participants which included the new members of the Steering Committee. He briefly explained about the background of constitution of Steering Committee and role of the Committee in approval of new IWMP projects to be taken up by States and overseeing the implementation of IWMP.

2. Meeting started with the presentation by the State Representatives. The State wise position is as under:

**Rajasthan -**

(i) The Committee was apprised that during the 37<sup>th</sup> Steering Committee Meeting, the State representative proposed to take up 7.53 lakh ha during 2014-15 against the tentative target of 7.59 lakh ha allocated to the State. The Committee had observed that 387 posts were lying vacant at various levels. The State representative committed in the earlier meeting that these posts will be filled up on urgent basis. Secretary (LR) had also pointed out that during last meeting the State had not fulfilled the monthly expenditure commitments as proposed during Annual Action Plan Meeting. She directed the State to revise their Annual Action Plan and come with a realistic plan. During the 37<sup>th</sup> Steering Committee Meeting, it was decided to consider the project proposal in the next Steering Committee Meeting after fulfilling the commitments by the State. Now the State has come up with revised Annual Action Plan and fresh proposal along with PPRs for 141 projects covering an area of 7.48 lakh ha against the target of 7.59 lakh ha during 2014-15 for appraisal by the Committee.

(ii) The CEO SLNA, Rajasthan made the presentation on performance of the IWMP projects sanctioned to the State during 2009-10 to 2013-14.
