

2. Accordingly, sealed quotations are invited for the disposal of said vehicles on the terms and conditions mentioned below. In case you are interested in purchasing the above mentioned vehicles, you may submit your quotation **in the enclosed Proforma**. You are required to quote your offer for vehicles, the particulars of which are given in the Proforma. The quotation addressed to the undersigned in a sealed cover should reach this Department latest by **3.00 PM on 9th, December, 2011. The quotation will be opened at 4.00 PM on the same day (09.12.2011)**. The quotation should be sent to Under Secretary(A), Department of Land Resources, NBO Building, Nirman Bhawan, New Delhi. The cover should be prominently super scribed with the words "QUOTATION FOR PURCHASE OF CONDEMED VEHICLE No. _____". The vehicles will be available for inspection between 2.00 PM TO 4.00 PM on 7th and 8th December, 2011.


3. The quotation received in time will be opened in Room No. 3, Department of Land Resources NBO Building, Nirman Bhawan, New Delhi. The bidders or their representative (not more than one) may be present, if they so desire, at the time of opening of quotations.

4. The sale will be governed by the following conditions:

- (i) The bidder is required to pay **Earnest Money of 5000/- for each vehicle separately.**
- (ii) Earnest Money is payable by means of Demand Draft drawn in favour of PAO, Department of Land Resources, New Delhi (payment by cheque or cash shall not be accepted)
- (iii) Quotation received without demand draft towards Earnest money will not be considered and shall not be accepted.
- (iv) The successful bidder will be required to deposit the bid amount by means of Demand Draft drawn in favour of PAO, Department of Land Resources within one week of acceptance of the bid.



- (v) The Earnest Money of the successful bidder will be released only after he/she deposits the sale proceeds. Earnest Money will be forfeited if he/she fails to honor the bid. The earnest money of successful bidder will be returned after completion of sale process.
- (vi) The delivery of the sold vehicle will be arranged only after the successful bidder submits documentary evidence in support of residential status (Ration Card/Voters Identity Card in case of individual and Registration Certificate in case of firms etc.)
- (vii) The sold vehicle will be removed by successful bidder within 48 hours of depositing the money at their own expenses.
- (viii) The vehicle will be disposed of on "as is where basis is" and no guarantee for its worthiness or quality will be given by this Department.
- (ix) The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at is own cost expeditiously. This office will not be responsible for any lapse on his part in this regard.
- (x) The bidders will not be allowed to withdraw their bids, failing which their earnest money will be forfeited.
