
Sir,

I am directed to say that it is proposed to dispose of Staff Car No. DL – 2 CM 7798, Ambassador (August – 2003 make), fitted with CNG Kit on “as is where is basis”.

2. Accordingly, sealed quotations are invited for the disposal of the said vehicle on the terms and conditions mentioned below. In case you are interested for purchasing of the vehicle, you may submit your highest quotations in the enclosed proforma. You are requested to quote highest offer for above vehicle, the particulars of which may be filled in the proforma. The quotations addressed to the undersigned in sealed cover should reach to this Department upto 3.00 P.M. on 28.2.2014. The quotations received in time will be opened at 4.00 P.M. on the same day. The bidder or their representative (not more than one) may be present, if they so desire, at the time of opening of quotations. The quotation should be sent to the Under Secretary (Admn.), Department of Land Resources, NBO Building, Nirman Bhawan, New Delhi. The cover should be prominently super-scribed with QUOTATIONS FOR PURCHASE OF CONDEMNED VEHICLE. The vehicle will be available in the premises of NBO building, Nirman Bhawan, New Delhi. The vehicle can be inspected between 2.00 P.M. and 4.00 P.M. on 26.2.2014 and 27.2.2014.

3. The sale will be governed by the following conditions:

- i) The bidder is required to pay earnest money of Rs. 5000/- (Rupees five thousand only) in the form of Pay Order/Demand Draft in favour of the Pay and Accounts Officer, Department of Land Resources, New Delhi.
- ii) Quotations received without Earnest money will not be considered as valid and shall not be accepted.
- iii) The successful bidder will be required to deposit the bid amount by means of Pay Order/Demand Draft in favour of the Pay & Accounts Officer, Department of Land Resources, New Delhi, within one week of acceptance of the bid.
- iv) The earnest money of the successful bidder will be released only after the bidder deposits the sale proceeds. Earnest money will be forfeited if the successful bidder fails to honour the bid. The earnest money of the successful bidder will be returned after completion of sale process.



- v) The delivery of the sold vehicle will be arranged only after successful bidder submits documentary evidence in support of residential status (Ration Card/Voter Identity Card/Adhar Card in case of individual and Registration Certificate in case of firm) etc.
- vi) The sold vehicle will be removed by the successful bidder within 48 hours of depositing the money and at their own expenses.
- vii) The vehicle will be disposed of on "as is where is" basis and no guarantee for its worthiness or quality will be given by this Ministry.
- viii) The successful bidder will also be responsible for getting the Registration Certificate of the vehicle transferred in his name at his own cost expeditiously. The office will not be responsible for any lapse on his part in this regard.
- ix) The bidder must ensure that they are not related to any Government official personally or by proxy.
- x) The bidder will not be allowed to withdraw his bid, failing which the earnest money will be forfeited.
- xi) The Department reserves the right to accept or reject any/all of the quotations without assigning any reason.


